

#### **Directions from Bern main station**

Take Bus Nr. 12 **at the rear exit of Bern's main station (Welle)** in the direction of "Länggasse". Exit the bus at "Länggasse" (3 stops) and turn left into Fabrikstrasse when facing the direction of travel of the bus. Walk for about 500 metres. You will find the Hochschulzentrum vonRoll on your right.

Take Bus Nr. 11 **at the city exit of Bern's main station (Bahnhofplatz)** in the direction of "Güterbahnhof". Exit the bus at "Güterbahnhof" (4 stops) and turn right into Fabrikstrasse when facing the direction of travel of the bus. Walk for about 200 metres. You will find the Hochschulzentrum vonRoll on your left.

The conference language is English. Simultaneous translation German/French – English is available for the panel discussion "Opportunities for Swiss Legislation".

# Sustainable Solutions in Governing the Extractive Industries

The extraction, trade and consumption of metals, rare ores and fossil fuels have numerous social, economic, political and ecological implications for countries worldwide. Producers and users of these resources very often have diverging needs and interests, and therefore different priorities when it comes to issues of governance. The various actors between producers and consumers add considerably to the complexity.

Consequently, extractive industries are a much debated topic and often controversially so. Particularly given the global nature of the issue. With the increasing scarcity of energy and metal resources, sustainable solutions to dealing with extractive industries become ever more important and debates are often highly politicised. In such contested contexts, knowledge is one critical element to devise pathways to sustainable solutions.

With its anniversary conference, the KFPE addresses the topic of extractive industries through the lens of science and research partnerships. It does so by presenting reflections and results from case studies conducted in different geographic contexts. Philippe Le Billon, one of the most renowned scholars in this field and Ricardo Giesecke, former Minister for Environment of Peru, share particular insights into the extractive industries.

By serving as a platform for discussion and integrating the views of civil society, enterprises in the commodity sector and politics, the conference reaches beyond the scientific community. Initiating and facilitating dialogue among stakeholders is one of KFPE's core objectives. It builds on the strong conviction that joint research teams are a vital prerequisite to producing research findings which are especially suitable in tackling the challenges of global transformations.
