#### **VACANCY**

The Centre for Development and Environment (CDE) is an interdisciplinary research centre of the University of Bern. Its overarching goal is to produce and share knowledge for sustainable development in cooperation with partners in the global North and South. CDE conducts research to develop innovative concepts and solutions for the sustainable governance of resources. One of CDE's central concerns is to foster dialogue between science and society while contributing to global debates on sustainability and development.

CDE is leading the research project "Sustainable Trade Relations for Diversified Food Systems". The project starts on 1 July 2019 and is funded by the Swiss National Science Foundation (SNSF) as part of the National Research Programme NRP 73 "Sustainable Economy". Food systems are highly complex and interdependent. Transforming them into *sustainable* food systems will require multisectoral, multidisciplinary efforts. In this project, a team of lawyers, agronomists, geographers, and historians will examine how governments can improve their trade relations to foster diversified, sustainable food systems.

## **DUTIES**

- Cooperate closely with the project leaders and assist in coordination
- Cooperate with various experts from different academic backgrounds
- Present research findings at academic conferences and other events, and organize such events
- Engage with project advisors and stakeholders
- Occasionally contribute to University teaching in sustainability and law
- Manage the contents of the project's web page
- Integrate into CDE and become acquainted with its main research approaches
